

## RESOLUTION 10-02

### PEACHTREE CITY WATER AND SEWERAGE AUTHORITY SCHEDULE OF RATES, FEES AND CHARGES

Adopted on October 11, 2010

#### RATES:

##### Residential and Single Family:

Effective for all bills issued on or after December 1, 2010:

\$ 26.00 Base Bill  
plus  
\$ 4.65 per 1,000 gallons

##### Commercial, Industrial and Multi-Family:

Effective for all bills issued on or after December 1, 2010:

\$ 26.00 Base Bill  
plus  
\$ 6.15 per 1,000 gallons

#### CONNECTION FEES:

##### For all areas except the Wynnmeade/West Village Service Area:

Connection fees shall be \$1,750.00 per Equivalent Residential Connection (ERC). An ERC is considered to be equivalent to 300 gallons per day (gpd). ERC's shall be based on the estimated average daily flow from the project divided by 300 gpd. The attached table shall be used to calculate the average daily flow from the project.

##### For the Wynnmeade/West Village Service Area\*:

Connection fees for single family residential units shall be \$2,250.00 per Equivalent Residential Connection (ERC). Connection Fees for all other uses, including apartments, commercial or industrial, shall be \$3,050.00 per ERC. ERC's shall be based on the estimated average daily flow from the project divided by 300 gpd. The attached table shall be used to calculate the average daily flow from the project.

## **PERMIT, PLAN REVIEW AND INSPECTION FEES:**

A single permit fee shall be calculated on the basis of the number of feet of public gravity sewer in the project. The fee shall be \$2.25 per foot of public gravity sewer. For projects involving a pump station and force main, an additional fee of \$500.00 shall be charged.

## **SEPTAGE RECEIVING RATES:**

The charges for the treatment of septage shall consist of a two (2) part fixed fee plus a volumetric charge based on the actual volume treated. The charges will be:

## **ABNORMAL STRENGTH WASTE SURCHARGE RATES:**

Biochemical oxygen Demand (BOD)	\$ 0.82 per pound
Chemical oxygen Demand (COD)	\$ 0.41 per pound
Total Suspended Solids (TSS)	\$ 0.98 per pound
Grease in excess of ordinance limit	\$1,000.00 per event

**It is the policy of the Authority that they will review and adjust; as necessary, rates and fees every two (2) years.**

\* The Wynnmeade/West Village Service Area is defined generally as the geographic area north of Hwy. 54, east of Line Creek, south of the City of Tyrone, and west of the CSX railroad lines. This also included any flows that may come from areas outside these boundaries but flow to the Wynnmeade pump station.
