AUTHORITY MEMBER'S REPORT

John Dufresne updated the board on the Policy & Procedures manual. A discussion followed regarding the current status of the Tyrone Intergovernmental Agreement.

GENERAL MANAGER'S REPORT

Mr. Hogan updated the board on the installation of bar screens at the Rockaway plant and the Turner/Line Creek plant, the installation of the screen at the Rockaway septage receiving station, and the installation of reuse pumps and valves at the Turner/Line Creek plant. Other topics discussed included the belt press production and anticipated October 20th delivery, the pipe bursting and lining project in Wynnmeade, and the completed project at Planterra. Hogan also reviewed the monthly charts including revenues and expenditures. Phil Mahler initiated a short discussion regarding the usefulness of the financial information in current chart presentation. Mr. Mahler then noted that all division managers and the business manager should attend the monthly meetings to assure any questions that arise will be addressed promptly.

OLD AGENDA ITEM

01-16-02- Consider adjustment of PCWASA Retirement Plan (Revision and Clarification) -

1) Clarify the participation in the retirement plan to include the GM.

Phil Mahler motioned that the Board clarify the personnel manual to include that the general manager can participate in the retirement plan at WASA in addition to the private plan the Board has with the general manager, and this would codify the decision the Board has already made in executive session a couple years ago on the same matter. Wes Saunders seconded the motion and a discussion followed. John Dufresne then made an amendment to the original motion. Dufresne motioned that subject to approval (of the original motion) to include the general manager in the plan to be retroactive to the beginning of the current plan with Principal. Phil Mahler and Wes Saunders accepted the amendment. The amended motion passed 4-0.

2) Approve changes to the retirement contribution as recommended by the advisor, which are 8% contribution and matching employee contributions at 100% up to 8% of salary. Phil Mahler made a motion that the Board change the retirement contribution to 6% contribution by WASA, and matching employee contributions at 75% up to 8% of salary. The motion was seconded by John Dufresne. Phil Mahler amended the original motion to include the change in contributions to begin October 1, 2016. The amended motion was seconded by John Dufresne and passed 4-0.
